**Arlington, Virginia – JANE FRANKLIN DANCE** announces a call for choreographers for a special one-time performance on Saturday, January 7, 2006, at 8:00pm at Gunston Theater One in Arlington, Virginia. This performance marks the culmination of the day-long Dance Sampler, a diverse array of workshops for dancers of all ages & experience, also held at Gunston Theater One.

Selected choreographers will be asked to teach a one hour workshop in their area of expertise during the one-day festival. To apply, send a VHS tape or DVD of your completed work, or work-in-progress, a brief description of a proposed workshop, a \$25 submission fee, and a self-addressed stamped envelope for return of materials to: Jane Franklin Dance, 3700 S Four Mile Run Drive, Arlington VA 22206. Submission deadline is October 1, 2005. Selected choreographers receive publicity, technical support and a \$125 stipend. Submission of experimental and premier works in any dance style is encouraged. For additional information call (703) 298-3235.

Workshops planned for the Dance Sampler include “Anti-Leotard Beginners”, a young dancers workshop for ages 7-14 (a sampling of the Young Dancers Project), and Adult-child one-on-one partnering with a JFD company member.

**Jane Franklin Dance** is based in Northern Virginia in Arlington County. The company has been presented at the Kennedy Center Millennium Stage, Clarice Smith Performing Arts Center, Dance Place, Grace Street Theater, Old Dominion University's Choreographers' Showcase, Richmond's "Yes, Virginia-Dance!" and other state and regional venues. Collaborative projects with poetry, live music, community participation and visual art have received funding in multiple years from the Virginia Commission, the Alexandria Commission, the Arlington Commission for the Arts, American Composers Forum - Washington DC Chapter and from foundations including Arlington Community Foundation, Washington Forrest Foundation and William D. Euille Foundation. Outreach includes educational performances and workshops for Young Audiences and for Arlington's Humanities Project. A STAR Award recipient for "Outstanding Community Outreach," JFD's ongoing projects include *Concert for Community* for Senior Adult and other community groups and *Young Dancers Project* for youth ages 7-14. *Jane Franklin Dance* has been recognized by Metro DC Dance Awards, Virginia's Governor's Award for Excellence in the Arts and the company tours for the Virginia Museum of Fine Arts Paul Mellon Arts in Education Program and the Virginia Commission's Tour Directory.
