Greetings Parents!

We're so glad you chose to enroll your child in Jane Franklin Dance's The Big Meow Summer Camp. We are sending you a package of information so you can be more fully informed about Camp expectations and policies.

Your Camp will take place the week of **July 16th-July 20** **camp hours are 9-4pm**. Per Arlington County's policy no child under the age of 10 may be unattended. Please make sure you or another responsible adult walks your child into the building for drop-off and pick-up. They may not be dropped off or picked up in the parking lot.

You will need to send with your child each day: Snacks (they will have two breaks for snack), Lunch, Loose clothing that they can be active in, and water to ensure that they stay hydrated through their day of dancing. Even though your child will mostly be in the dance studio during the day please make sure they arrive in sneakers should we need to have some form of foot covering.

If your child is participating in the before or after care sessions please drop them off **no earlier than 8am for before care and pick them up no later than 6pm for after care**. Feel free to provide your child with a favorite book, stuffed animal, small toy, or no mess art supplies i.e. coloring book and crayons if they are going to be in the building for before and/or after care.

Also you will find in this packet a **waiver form** which we ask you to sign and return to us. Your child will not be able to participate without a parent signature on this document. Additionally there is an **Emergency Contact form** that we also ask that you fill out and return to us to ensure the continued safety of your child.

No refunds for summer camp after June 1st. Refunds made before June 1st are subject to a \$35 administrative fee per camp session. Jane Franklin Dance is a 501(c) 3 non-profit organization and **cannot provide refunds**. In the event of camper illness we cannot offer a refund and provide no make-up policy.

Further, I am aware that dance is a vigorous activity and may pose a risk injury. I understand that dance and related activities always involve certain risks, including but not limited to, death, serious neck and spinal and related injuries resulting in complete or partial paralysis, brain damage, and serious injury to virtually all bones, joints, muscles, and internal organs. The risk of harm may be limited by all of the safety equipment and trained professionals, but never eliminated. I understand that participation in dance and related activities involves activities incidental to active participation in dance and related activities including conditioning, stretching, and other activities which may leave me vulnerable to the reckless actions of other participants who may not have complete control over their actions. I am voluntarily participating in this activity with knowledge of the risks involved and hereby agree to accept any and all inherent risks of property damage, personal injury, or death.

I further agree to indemnify and hold harmless Jane Franklin Dance and all others listed for any and all claims arising as a result of my engaging in performances, rehearsals, demonstrations, workshops or special events with Jane Franklin Dance or any activities incidental thereto, whenever, wherever, or however the same may occur. *Also, I give my permission for video and stills taken by the official videographer and photographer during this event to be used for promotional purposes.*
